



#### ▲ Manager's Comment

In May, with the decline in inflation data and weaker economic indicators, US bond yields fluctuated down by approximately 20 basis points. The Federal Reserve announced during its monetary policy meeting that it would slow down the pace of balance sheet tapering. In Asia, the outcome of the Indian elections showed a smaller advantage for Prime Minister Modi than expected. The Chinese government, in collaboration with various departments, introduced a series of policies to support the real estate market. The bond market performed well overall, with the JACI Core Index rising by 1.41%.

It is expected that the overall economic conditions in the Asia region will remain relatively strong in the second half of 2024. Asian investors continue to show enthusiasm for investing in Asian and global dollar bonds. There are favorable opportunities for allocation in Asian bond assets given the high interest rates and potential for interest rate cuts. We will also actively adjust relevant positions based on the implementation of real estate policies.
