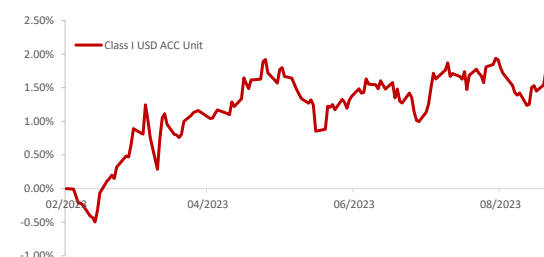

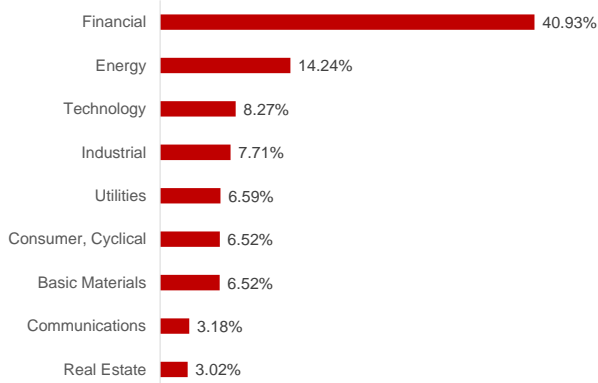

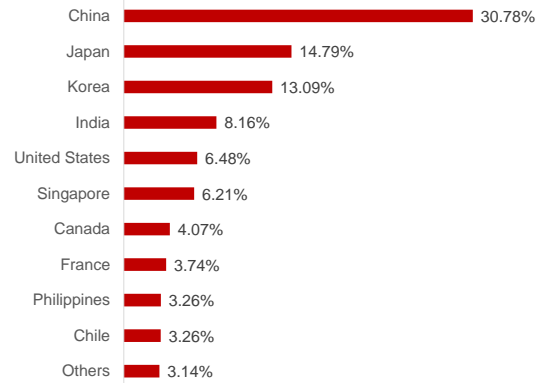


▲ Portfolio Allocation

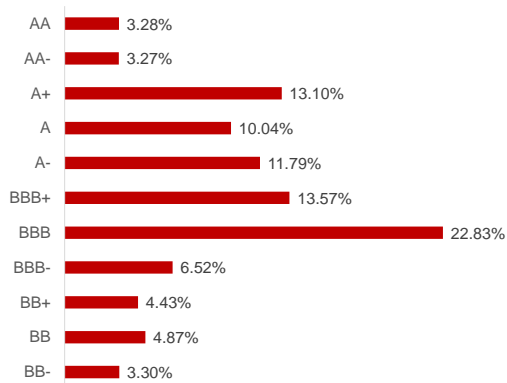
Sector Exposure (%)



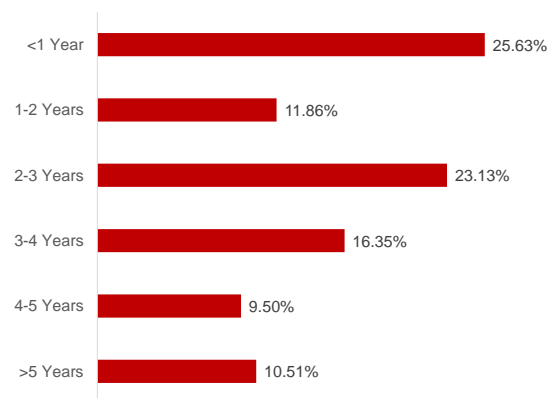
Geographical Exposure (%)
