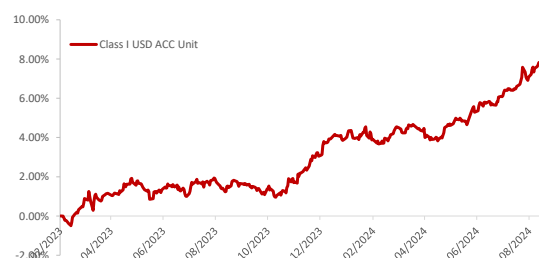

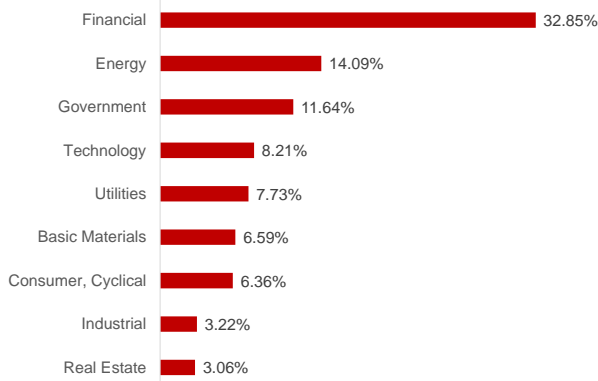

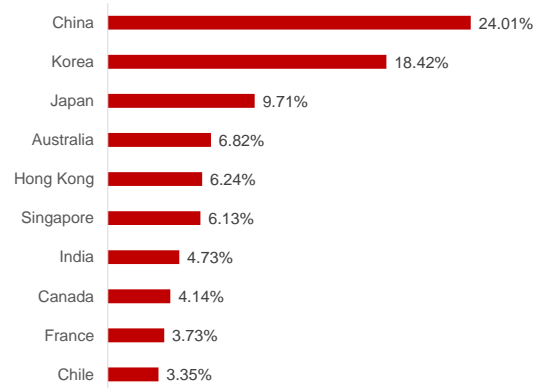


### ▲ Portfolio Allocation

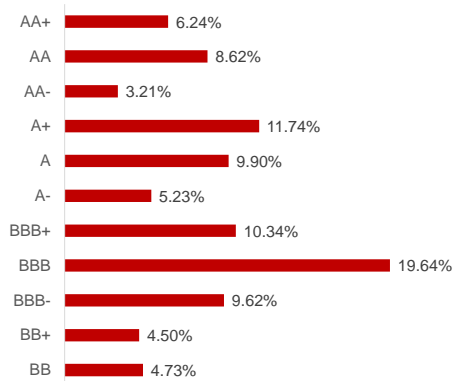
#### Top 10 Sector Exposure (%)



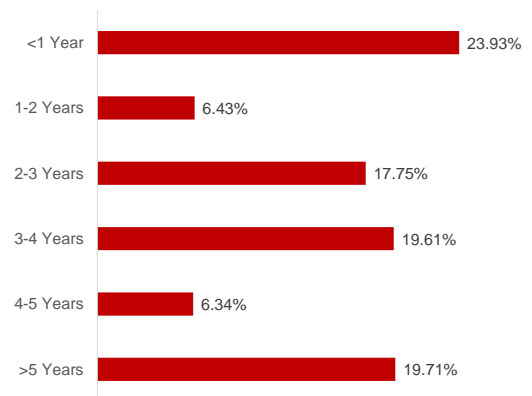
#### Top 10 Geographical Exposure (%)
