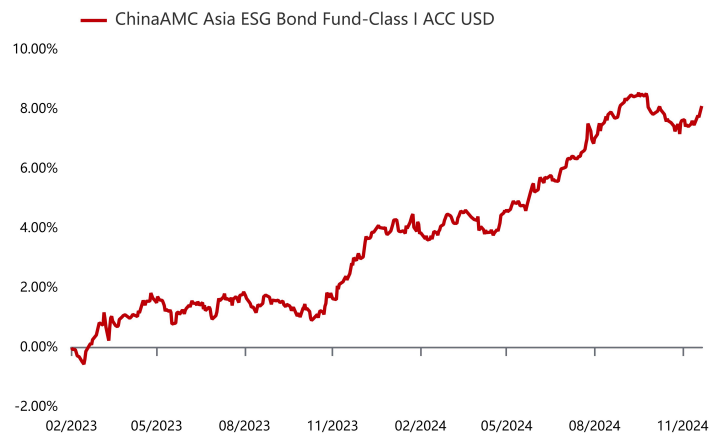

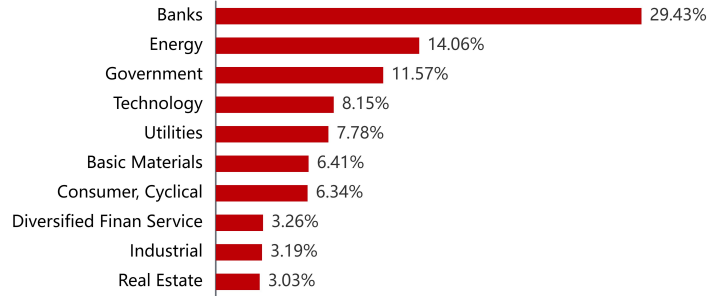

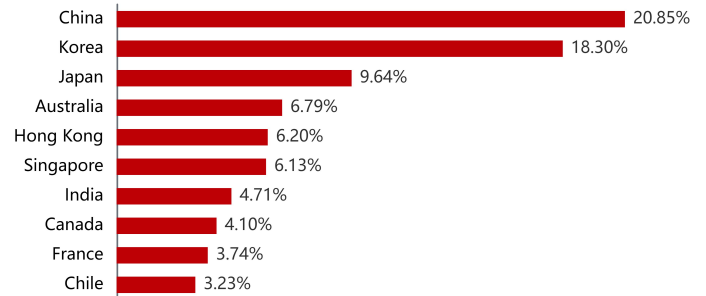

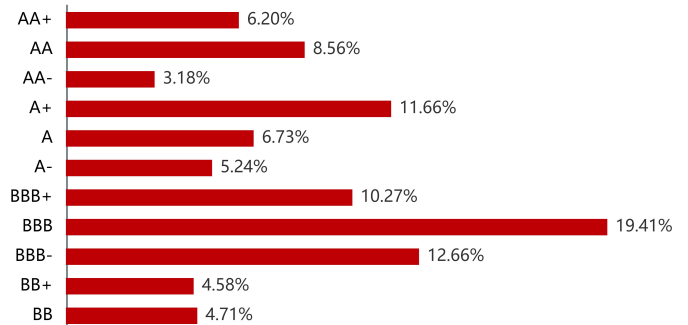
Top 10 Sector Exposure (%)



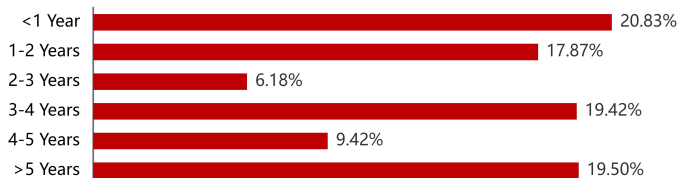
Top 10 Geographical Exposure (%)
