▲ Investment Objective

The Fund seeks to achieve capital appreciation and income generation by investing primarily in onshore RMB denominated equity securities issued by issuers based in, or having a significant exposure to, Mainland China and Hong Kong, as further described below. The Investment Manager contemplates investing directly into China A-Shares using its QFI status and the Stock Connect. As at the date of the Fund's prospectus, the Investment Manager, when using Stock Connect, will be limited to investments in China A-Shares listed on the SSE and the SZSE.




▲ Manager's Comment

In March 2025, the Wind All Share Index fell by 0.4%, the CSI 300 Index by 0.07%, the ChiNext Index by 3.07%, while the Hang Seng Index rose by 0.78% and the Hang Seng Tech Index fell by 3.11%. The performance of the US indices, including the Dow Jones, S&P 500, and Nasdaq, were -4.2%, -5.75%, and -3.97%, respectively. The Chinese stock market continued to outperform the US stock market, while the Hong Kong stock market slightly outperformed the A-shares. However, the technology sector represented by the Hang Seng Tech Index was not as strong as in the previous two months. In terms of industry sectors, energy, materials, utilities, consumer, and pharmaceuticals outperformed, while real estate, information technology, and communication services underperformed.

In March, the A-shares experienced a slight decline, with the first half of the month seeing a volatile upward trend and the second half experiencing a volatile adjustment. The market maintained a daily turnover of over 1 trillion RMB, and the China Purchasing Managers' Index (PMI) continued to stay in the expansion zone. The Two Sessions held in the first half of March, although the policies were generally in line with market expectations, emphasized timely and sufficient policies and a positive tone to guide market optimism about subsequent economic recovery. The trend and enthusiasm for IPOs in Hong Kong continued to strengthen, with some newly listed IPO stocks performing well, driving the market's volatile upward trend in the first half of March. However, large-scale corporate financing began to appear, with BYD, Xiaomi, and NIO raising 43.5 billion, 42.6 billion, and 4 billion HKD respectively in March, raising concerns about the adjustment of technology stocks and stocks that had risen significantly earlier. Industry performance began to diverge. Additionally, global trade tensions started to escalate, with the US imposing a 25% tariff on European steel and aluminum in mid-March, and the EU announcing phased retaliatory tariffs on US goods worth 26 billion euros on the same day. The US President's declaration of the "reciprocal tariff" policy to be implemented in April also increased market concerns, leading to continued market adjustments in the second half of the month.

Looking ahead, we still believe that the core issue of the Chinese stock market is the recovery of China's economy itself, with geopolitical and international monetary environment having marginal impacts that will not significantly affect the direction of the Chinese market. If the external environment deteriorates suddenly, the Chinese government may strengthen domestic demand policies and use policy tools to stabilize the market. In the current environment, our view on Chinese assets has changed, and policies will support the economy; we expect moderate economic recovery, which will support the market upward, and buying opportunities will arise once external events stabilize. In the short term, we will respond to market uncertainties and start more actively selecting stocks amid volatility, with a particular focus on the pharmaceutical, technology, and manufacturing sectors
