- ChinaAMC Select Greater China Technology Fund (the "Fund") will invest primarily in China-Related Technology Companies and in the opinion of the Manager, will likely benefit from innovations, use of new technologies or offering products and services that meet the demands of the new and evolving China economy ("China-Related Technology Companies"). The Fund may invest a small portion of its assets in fixed income securities, equities listed on stock exchanges around the world other than the Greater China, other collective investment schemes and invest directly in Mainland China securities.
- The Fund will invest in equity securities and is subject to general market risk and the prices of such securities may be volatile.
- The Fund may also invest in companies of any market capitalization including but not limited to companies with small or medium market capitalization. The stocks of companies with small or medium market capitalization may have lower liquidity and their prices are more volatile to adverse economic developments than those of larger market capitalization companies in general.
- The Fund will focus its investments on China-Related Companies and such investments will increase the Sub-Fund's vulnerability to the economic, political or regulatory or tax developments of a single country such as China. Also, the Fund is likely to be more volatile than a fund having a more diverse portfolio of investments.
- The Fund may invest in the PRC markets, which involve certain risks and special considerations not typically associated with investment in more developed economies or markets, such as greater political, tax, economic, foreign exchange, liquidity, legal and regulatory risk.

▲ Investment Objective

The Fund seeks to achieve long term capital growth by primarily (i.e. not less than 70% of its Net Asset Value) investing in China-Related Technology Companies (as defined below). To achieve the investment objective, not less than 70% of the Fund's Net Asset Value will be invested in equities of technology companies which, in the opinion of the Manager, will likely benefit from innovations, use of new technologies or offering products and services that meet the demands of the new and evolving China economy ("China-Related Technology Companies") with registered offices located in the Greater China area (including Mainland China, Hong Kong, Macau and Taiwan), and/or China Related Technology Companies that do not have their registered offices in the Greater China area but either (a) carry out a predominant proportion of their business activities in Greater China or (b) are holding companies which predominantly own companies with registered offices in Greater China.

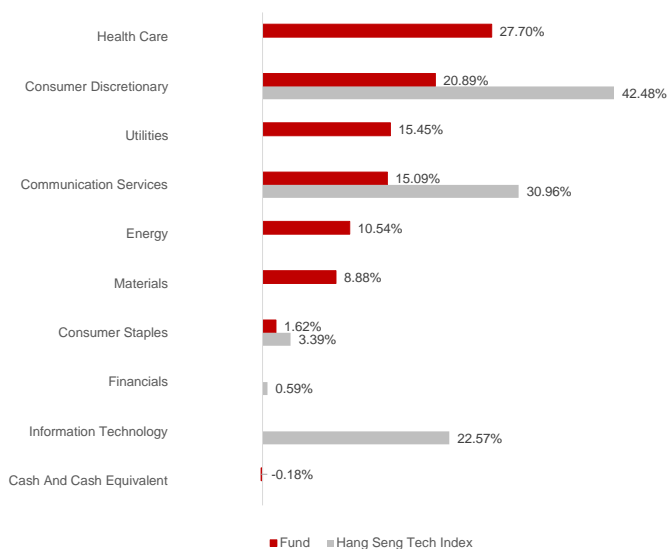

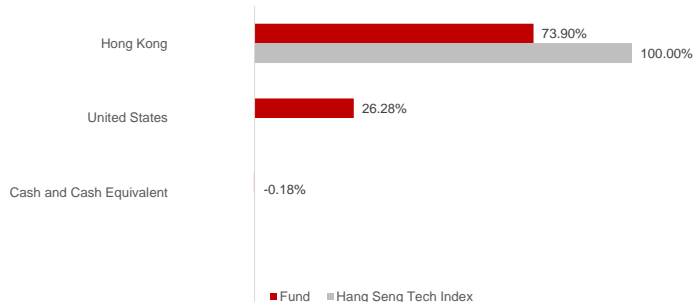


▲ Portfolio Allocation

▲ Manager's Comment

The Hang Seng Tech Index rose by 6.42% in April. The Central Committee of the Communist Party of China held a meeting and affirmed the relatively good performance of the macroeconomy. They emphasized the need to effectively implement established macro policies, including an active fiscal policy and a prudent monetary policy. The policymakers aimed to avoid a "tightening after loosening" approach and consolidate the positive momentum of economic recovery. They discussed policies related to existing housing stock, optimization of new housing supply, and the promotion of high-quality development in the real estate sector, addressing key concerns in the market and boosting confidence among participants.

Due to factors such as the depreciation of the Japanese yen and short-term adjustments in developed stock markets, some funds increased their allocation to the Chinese market. Despite the limited improvement in the fundamentals of most companies in the near term, stock prices rose rapidly since late April driven by the availability of funds. The Hang Seng Index has experienced a rare 10-day consecutive increase. Companies in the Hang Seng Tech Index, particularly large-cap internet firms, benefited from increased allocation due to their relatively lower valuations and higher weightings in major Chinese market indices.

The fund's performance in April lagged behind the Hang Seng Tech Index. The fund achieved negative excess returns in the healthcare, communication services, energy, and financial sectors in terms of industry allocation and in the consumer discretionary, information technology, and consumer staples sectors in terms of stock selection. It recorded small positive excess returns in the consumer staples, materials, and utilities sectors in terms of industry allocation, as well as in the financial and communication services sectors in terms of stock selection. The fund will continue to adhere to a prudent and sustainable investment approach, aiming to achieve better performance in the medium to long term through reasonable industry allocation and bottom-up stock selection.

Looking ahead, the investment manager maintains a positive view on the market's medium to long-term performance. However, after the recent rapid increase, the market has temporarily moved away from being extremely undervalued. The potential for further valuation improvement in the short term is limited, and the continued improvement in economic expectations and corporate earnings will be crucial for the market's upward trajectory. The investment manager will closely monitor changes in factors such as exchange rates and expectations of overseas interest rate cuts, which may impact the flow of external funds, to better grasp short-term market trends. The fund will continue to adopt a relatively active investment strategy and enhance its ability to capture alpha opportunities at the individual stock level, aiming to diversify and stabilize portfolio investment returns in a complex market environment.
