

▲ Manager's Comment

high-quality development.

In June, the Hang Seng Tech Index in Hong Kong fell by 3.69%. The market experienced a downward trend throughout the month, with most high-frequency economic data weakening. Investors became more cautious about economic growth expectations, and coupled with the depreciation of the Chinese yuan against the US dollar, market risk appetite significantly declined.

On June 25, Premier Li Qiang attended the opening ceremony of the 2024 Summer Davos Forum and emphasized the need to always grasp the direction of building an open world economy. He highlighted the importance of consolidating the foundation and enhancing the basic support capabilities for economic development. He also mentioned the need to combine short-term and long-term measures to promote

On June 26, the State Council Information Office held a regular policy briefing, where they proposed the formation of a comprehensive system to support the high-quality development of entrepreneurial investment. They aimed to guide long-term funds such as insurance funds to invest in entrepreneurial ventures and create a more favorable market environment for entrepreneurial investment. On the same day, Premier Li Qiang presided over an executive meeting of the State Council, where they discussed utilizing foreign investment. They emphasized the deepening of opening up in key areas, implementing the "zero restrictions" on foreign access in the manufacturing sector, and launching a new round of pilot measures for the expansion of the service industry.

On June 27, the Politburo of the Communist Party of China's modernization. They also decided to convene the third plenary session of the 20th Central Committee of the Communist Party of China from July 15 to 18 in Beijing.

Looking ahead, investment managers maintain a positive outlook on the market's medium to long-term performance. After the implementation of the new real estate policies on May 17, real estate sales in major first-tier cities have shown signs of recovery, but the sustainability is still to be observed. Some internet and consumer companies have faced short-term pressure on profit growth due to weather factors and macroeconomic pressures, resulting in weaker stock price trends. However, undervalued stocks and gradually improving shareholder return measures are expected to provide support to stock prices. The commercialization progress of Apple's All products has sparked investors' enthusiasm for edge Al, benefiting semiconductor and consumer electronics-related companies. The upcoming Third Plenum and the end-of-July Politburo meeting on economic and policy matters will be the short-term focus of the market. It is expected that the market will continue to trade within a range, and investment managers will actively seize investment opportunities at the individual stock level. Funds will continue to adopt a relatively proactive investment strategy while enhancing the capture of alpha opportunities at the individual stock level to improve the diversity and stability of portfolio investment returns.
