- ChinaAMC Select Greater China Technology Fund (the "Fund") will invest primarily in China-Related Technology Companies and in the opinion of the Manager, will likely benefit from innovations, use of new technologies or offering products and services that meet the demands of the new and evolving China economy ("China-Related Technology Companies"). The Fund may invest a small portion of its assets in fixed income securities, equities listed on stock exchanges around the world other than the Greater China, other collective investment schemes and invest directly in Mainland China securities.
- The Fund will invest in equity securities and is subject to general market risk and the prices of such securities may be volatile.
- The Fund may also invest in companies of any market capitalization including but not limited to companies with small or medium market capitalization. The stocks of companies with small or medium market capitalization may have lower liquidity and their prices are more volatile to adverse economic developments than those of larger market capitalization companies in general.
- The Fund will focus its investments on China-Related Companies and such investments will increase the Sub-Fund's vulnerability to the economic, political or regulatory or tax developments of a single country such as China. Also, the Fund is likely to be more volatile than a fund having a more diverse portfolio of investments.
- The Fund may invest in the PRC markets, which involve certain risks and special considerations not typically associated with investment in more developed economies or markets, such as greater political, tax, economic, foreign exchange, liquidity, legal and regulatory risk.

▲ Investment Objective

The Fund seeks to achieve long term capital growth by primarily (i.e. not less than 70% of its Net Asset Value) investing in China-Related Technology Companies (as defined below). To achieve the investment objective, not less than 70% of the Fund's Net Asset Value will be invested in equities of technology companies which, in the opinion of the Manager, will likely benefit from innovations, use of new technologies or offering products and services that meet the demands of the new and evolving China economy ("China-Related Technology Companies") with registered offices located in the Greater China area (including Mainland China, Hong Kong, Macau and Taiwan), and/or China Related Technology Companies that do not have their registered offices in the Greater China area but either (a) carry out a predominant proportion of their business activities in Greater China or (b) are holding companies which predominantly own companies with registered offices in Greater China.

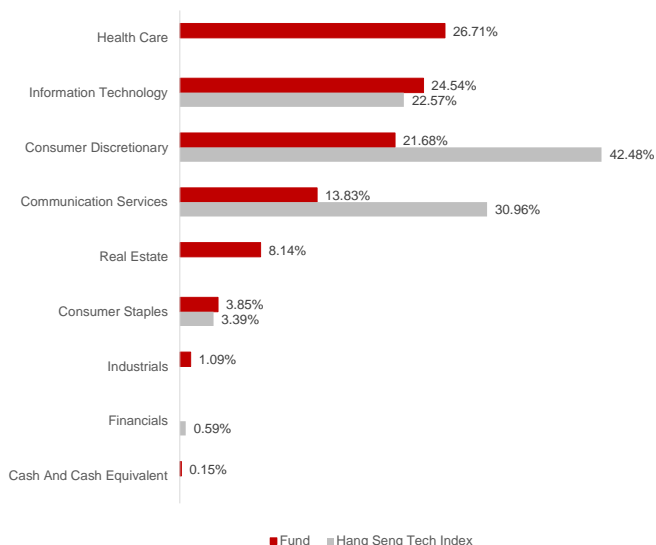

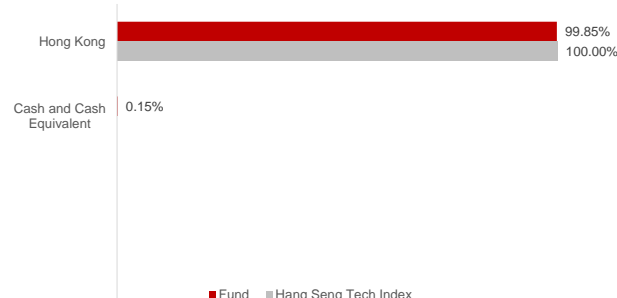


▲ Portfolio Allocation

▲ Manager's Comment

In July, the Hang Seng Technology Index fell by 1.06%, and the overall market continued to show volatile downward trends. Most high-frequency economic data remained weak, with investors maintaining a cautious outlook on China's economic growth and a low appetite for risk. China's GDP growth in the second quarter was 4.7% year-on-year, below the expected 5.1%, highlighting a widening gap between domestic and external demand, further exacerbating supply-demand contradictions. In June, industrial value-added above a certain scale grew by 5.3% year-on-year, surpassing the expected 5.0%. However, production growth in export-related industries remained high but continued to decline marginally. Fixed asset investment in June grew by 3.9% year-on-year, in line with expectations, mainly driven by infrastructure investment. Total retail sales of consumer goods in June increased by 2% year-on-year, showing a significant slowdown as demand was partially exhausted ahead of the 618 shopping festival, with physical and dining consumption remaining weak. Economic data for the second quarter indicates that economic recovery requires further fiscal policy efforts.

The Third Plenum was held from July 15th to 18th, with the content of the communiqué generally meeting expectations, setting the direction for further comprehensive deepening of reforms and advancing China's modernization. On July 30th, the Central Political Bureau meeting highlighted the increasing adverse impacts of changes in the external environment, insufficient effective domestic demand, economic divergence, numerous risks in key areas, and transitional challenges in old and new growth drivers. It emphasized the heavy tasks for the second half of the year, promoting high-quality development, intensifying macroeconomic regulation efforts, and resolutely achieving the annual economic and social development goals.

Looking ahead, fund managers maintain a positive outlook on the market's medium to long-term performance. On July 22nd, China's 1-year Loan Prime Rate (LPR) was 3.35%, and the 5-year LPR was 3.85%, both down by 10 basis points from the previous value. This adjustment, after four consecutive months of unchanged LPR, indicates the People's Bank of China's accommodative policy stance while also suggesting constraints from multiple balancing objectives on policy space. It is expected that there is still room for further LPR cuts this year. Additionally, the National Development and Reform Commission and the Ministry of Finance issued a notice regarding measures to support large-scale equipment upgrades and consumer goods replacement, aiming to enhance investor expectations of the Chinese economy by increasing the fiscal interest subsidy ratio for equipment upgrades and expanding the scope and intensity of subsidies for equipment and consumer goods. Despite short-term economic pressures and subdued market sentiment, the undervaluation of the Hong Kong stock market and improving shareholder returns are expected to provide downside protection to the market. It is anticipated that the market will continue to exhibit range-bound trading patterns, with fund managers actively seizing individual stock investment opportunities. Funds will continue to adopt a relatively proactive investment strategy, while enhancing the capture of alpha opportunities at the individual stock level in a complex market environment, thereby improving the diversification and stability of portfolio investment returns.
