- ChinaAMC Select Greater China Technology Fund (the "Fund") will invest primarily in China-Related Technology Companies and in the opinion of the Manager, will likely benefit from innovations, use of new technologies or offering products and services that meet the demands of the new and evolving China economy ("China-Related Technology Companies"). The Fund may invest a small portion of its assets in fixed income securities, equities listed on stock exchanges around the world other than the Greater China, other collective investment schemes and invest directly in Mainland China securities.
- The Fund will invest in equity securities and is subject to general market risk and the prices of such securities may be volatile.
- The Fund may also invest in companies of any market capitalization including but not limited to companies with small or medium market capitalization. The stocks of companies with small or medium market capitalization may have lower liquidity and their prices are more volatile to adverse economic developments than those of larger market capitalization companies in general.
- The Fund will focus its investments on China-Related Companies and such investments will increase the Sub-Fund's vulnerability to the economic, political or regulatory or tax developments of a single country such as China. Also, the Fund is likely to be more volatile than a fund having a more diverse portfolio of investments.
- The Fund may invest in the PRC markets, which involve certain risks and special considerations not typically associated with investment in more developed economies or markets, such as greater political, tax, economic, foreign exchange, liquidity, legal and regulatory risk.

▲ Investment Objective

The Fund seeks to achieve long term capital growth by primarily (i.e. not less than 70% of its Net Asset Value) investing in China-Related Technology Companies (as defined below). To achieve the investment objective, not less than 70% of the Fund's Net Asset Value will be invested in equities of technology companies which, in the opinion of the Manager, will likely benefit from innovations, use of new technologies or offering products and services that meet the demands of the new and evolving China economy ("China-Related Technology Companies") with registered offices located in the Greater China area (including Mainland China, Hong Kong, Macau and Taiwan), and/or China Related Technology Companies that do not have their registered offices in the Greater China area but either (a) carry out a predominant proportion of their business activities in Greater China or (b) are holding companies which predominantly own companies with registered offices in Greater China.

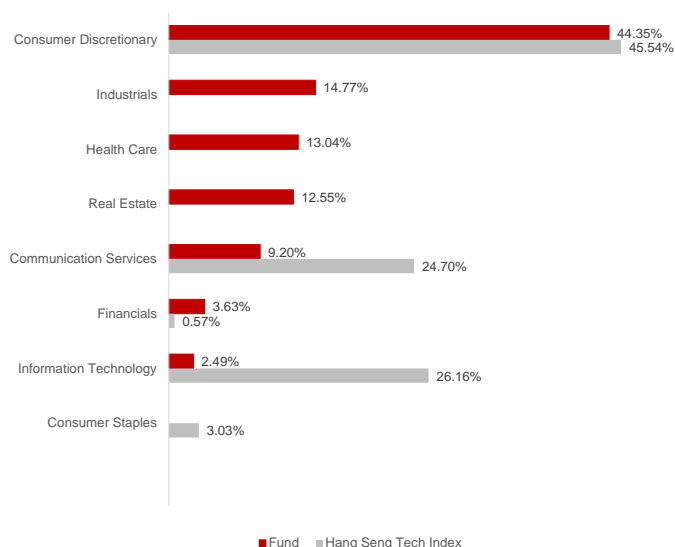

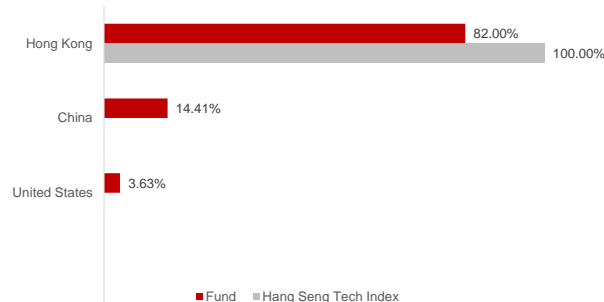


▲ Portfolio Allocation

▲ Manager's Comment

The Hang Seng Tech Index fell by 5.32% in October, influenced by uncertainties surrounding the U.S. election and China's stimulus policies, causing market volatility and a decline. On October 8, at a press conference of the National Development and Reform Commission (NDRC), it was announced that 20 billion yuan would be allocated by the end of October to support local investment projects to start construction ahead of schedule, along with measures to expand the scope of support for local government special bonds. On October 12, the Ministry of Finance stated that 400 billion yuan would be allocated from the balance of local government debt to supplement local government finances, emphasizing that there is still significant room for central government deficit expansion and that a major measure to support debt conversion would be introduced.

On October 17, during a press conference, the Ministry of Housing and Urban-Rural Development reiterated the policy of "monetizing resettlement," announcing plans to implement an additional 1 million units of urban village and dilapidated house renovations, with loan approvals for "white-listed" projects expected to increase to 4 trillion yuan by the end of the year. On October 25, the State Council executive meeting emphasized the importance of continuing to implement a package of incremental policies, increasing countercyclical adjustments, and further enhancing macroeconomic regulation effectiveness. The NDRC stated on October 23 that more incremental policy measures would be introduced, including expanding the scope of special bond investments and areas, scale, and proportion where special bonds can be used as capital.

Looking ahead, investment managers maintain a positive view on the market's medium to long-term performance. With Trump's election as U.S. president, subsequent Chinese domestic demand stimulus policies are expected to strengthen to offset the potential negative impact of tariff increases on China's economic growth. During a press conference at the 12th meeting of the 14th National People's Congress Standing Committee on November 8, Finance Minister Lan Fo'an stated that starting from 2024, 80 billion yuan would be allocated annually from newly issued local government special bonds for five consecutive years to supplement government fiscal resources specifically for debt conversion, totaling 4 trillion yuan in hidden debt substitution. In addition to the approved 6 trillion yuan debt limit by the National People's Congress Standing Committee, an additional 10 trillion yuan in local debt resources would be directly added; it was also clarified that the 2 trillion yuan hidden debt for shantytown redevelopment due in and after 2029 would still be repaid according to the original contract. Lan Fo'an also mentioned active planning for the next step of fiscal policy, emphasizing increased countercyclical adjustment efforts and implementing a more forceful fiscal policy in line with next year's economic and social development goals.

Currently, the overall market valuation level is relatively reasonable, and there is potential for further strengthening of demand-side policies, expecting numerous structural opportunities. Funds will continue to adopt a relatively proactive investment strategy while enhancing the grasp of alpha opportunities at the individual stock level in a complex market environment, aiming to improve the diversity and stability of portfolio investment returns.
